Te Ture Whenua Tika iio Nga Tangata Whenua

Kei a ratoa te mana tuko Miru, Raharaha, Tipene, Mau Rakau Haapu Whanau

Whanaungatia ka uru te tika ma te mana whakahaere I nga patea whenua.

Ko te ukaipo te wahi, te tangata ranei e whangai ana I te ora, I te haa o te tangata. I te horopaki o te pepi ma te uu.

Engari, I te tikanga whanui whanui, ko te ukaipo hoki te puna o te manakitanga, o te ha ora me te hononga ki te whenua me te whanau.

Ko te tangata whangai e kai ana te kai pakeke, kua puta I te wa pepi pea, kua timata ki te kai I nga momo kai e hangai ana ki te pakeketanga o tona tinana. E tohu ana tenei I te whakawhanaungatanga me te tipu haere o te tangata, katahi ka tau ki nga kai e whakawhanui ake ana I tona oranga me tona kaha.

Te Kooti Marae

Ko te Kooii Marae he wahi nei whakataau rongoa me te whakaroa mo nga whanau me nga hapu, ma te whakamahi I nga tikanga Maori hei whakahou I te mana me te whakatau I nga raru l waenga I te tangata, te hapori, kia noho ai te rangimarie me te oranga ki te runga rawa me te whenua.

Ko te paepae

Kei runga I te marae e noho ai te kuia kaumatua me nga kaitirotiro o te kooti. He papa tuu ahua tikanga, ka noho ratou hei kaiarahi me te kaiwhakatu I nga korero me nga tikanga I nga huihuinga o te marae. I te ao Maori, ko te paepae te wahi o te mana me te rangatiratanga. Ko te paepae e tohu ana I te paeroa whakahaere o te hapu I runga I nga tikanga Rangatira. Ka rongo I nga korero o te hapu nga karakia, me nga whaikorero I runga I te mana o te whenua me nga kaupapa tuku iho.

The following Act, the **Land Transport Act 1998 and amendments,** is hereby altered, added to and replaced and these changes are now permanent and unamendable by special resolution in accordance with the tikanga of our Aio Haapu Whanau as follows;

the Land Transport Act 1998 and amendments, s2 Interpretation

(1) In this Act, unless the context otherwise requires,— **driver,** in relation to a vehicle, only refers to a participant engaging in commercial activity not personal transport; and **drive** has a corresponding meaning.

driver licence means a licence to drive that is issued or has effect under this Act but only refers to a participant engaging in commercial activity not personal transport; and includes an endorsement on a driver licence.

enforcement officer means—

- (a) a constable:
- (b) a Police employee who is not a constable who is authorised for the purpose by the Commissioner:
- (c) a person who is appointed to that office by warrant under section 208 or who holds that office by virtue of this Act:
- (d) the Agency, in the circumstances set out in section 208A; and
- (e) each and every one of these shall recognise the superior jurisdiction and authority of every man and woman and kaitiaki and tangata whenua and that, without a contract to show otherwise, no man and woman or kaitiaki and tangata whenua shall be considered a person within the meaning of the Acts

evidence of vehicle inspection, in relation to a vehicle, means any certificate, label, or document issued under this Act as evidence of the completion of the periodic vehicle inspection requirements in respect of that vehicle, but only refers to commercial activity vehicles not personal transport machines or contraptions

kaitiaki means tangata whenua and man and woman and boy and girl and people.

motor vehicle—

- (c) does not include—
 - (ii) any personal transport machine or contraption
- (ix) any attachment to a personal transport machine or contraption that is intended to carry personal materials or items **motorcycle**—
- (a) means a motor vehicle running on 2 wheels, or not more than 3 wheels when fitted with a sidecarbut does not mean any 2 or 3 wheeled personal transport machine or contraption.
- **operate**, in relation to a vehicle only but does not include any personal transport machine or contraption, means to drive or use a vehicle on a road, or to cause or permit the vehicle to be on a road or to be driven on a road, whether or not the person is present with the vehicle; and **operator** has a corresponding meaning.

participant, in relation to the land transport system, means a person who does anything for which a land transport document is required

but does not mean any man or woman or boy or girl or kaitiaki or tangata whenua.

permanent speed limit means a speed limit that is in force except when a seasonal, variable, minimum, emergency, or temporary speed limit is in force but does apply to any personal transport machine or contraption.

person means a legal entity person only, it does not refer to or include man or woman or boy or girl or kaitiaki or tangata whenua.

property means property of every kind whether intangible, or personal, or incorporeal, and includes rights, interests, and claims of every kind in relation to intangible property however they arise.

speed limit means a speed limit set under—

(a) this Act, and applies to vehicles only but does not apply to personal transport machines or contraptions.

tangata whenua means kaitiaki and men and women and boys and girls and people.

vehicle—

(c) does not include—

(iv) any personal transport machine or contraption or any attachment to a personal transport machine or contraption that is intended to carry personal materials or items.

the Land Transport Act 1998 and amendments, 3 Act to bind the Crown

This Act binds the Crown.

the Land Transport Act 1998 and amendments,

13 Drivers and other road users to comply with directions of enforcement officers, etc

(6) this section does not apply to tangata whenua holding papers from any Whanau roōpu.

the Land Transport Act 1998 and amendments, 23 Issue of driver licences

(5) this section does not apply to tangata whenua holding papers from any Whanau roōpu.

the Land Transport Act 1998 and amendments, 169A Functions of Minister

The functions of the Minister under this Act are—

(a) to promote safety in land transport especially by ensuring New Zealand roads and bridges and other such infrastructure are fit for use and up to international standards by;

- (i) directing roadworks and bridge building to achieve and maintain international standards;
- (ii) delivering immediate funding to those groups, such as Maori Roopu and Maori Whanau, that are constructing, rebuilding and maintaining roads and bridges and other such infrastructure within their affected areas;
- (iii) such funding and any other material assistance as required shall be afforded within 28 days of formal notice given by groups such as Maori Roopu and Maori Whanau, to the Minister or any Land transport regional office:
